Broadway Corridor

Hwy 169/ Broadway Blvd & 5th/6th St morning and evening peak period traffic volumes and turning movements collected by MioVision and split calibrated to average 2016 and 2017 turning movement counts.

Hwy 169 turning movement and ramp counts collected by MioVision at Richards Road interchange and direct connections to Richards Road in vicinity of Wheeler Airport.

Broadway Blvd corridor turning movement counts for each major intersection south of 6th St and north of the I-670 EB ramp terminal were determined through the KCMO city-wide Synchro model.
